Aims & Objective

(i)To be one of the prime organizations of the world catering to human rights activities.

(ii)To organize VOICE working process by opening up different cells viz. Human Rights Helpline, Family Discipline, Advisory Centre, Public Justice Legal Aid Centre, Crime Prevention Team, Information Gain Centre, National and International Committee, Accident Relief Centre, Schedule Caste Help Centers, Mahila and Labour Welfare Centre, Helpless Medical Legal Relief Centre, Consumer Forum Centre, Inquiry Committee, Centre for Government's Project etc.

(iii)For the general welfare of all mankind without any distinction of caste, creed or religion.

(iv)Create awareness among the people so they can voice their complaints/grievances to VOICE against injustice. These complaints will be verified by VOICE for their validity and human right violations issues and carried forward for justice. Note: No fee is chargeable on complaints.

(v)To bring under the banner of human rights, all the possible people of the world. This trust appeals to the national and international people to join VOICE and give some time for human rights cause.

(vi)To continue working to maintain the formed society. This will be by activities viz. Legal literacy awareness, Medical reliefs, Lokadalat, Janta Darbar with the support of National Legal Service Authority, many Ayog centres and State Government Administration, with the support of many National and International status committees, councils, UNO, NALSA, NGO, social workers, Central and State government's NRI etc.

(vii)VOICE helps those who helps themselves. In this globalization period, intellectual people have a duty to help and save those below poverty line, Slum people, illiterate and poor helpless people have been cut-off from the main line of national and international body.

(viii)To work as RTI Activist including to seek information, file appeals, complaints, get compensation, to file and pursue complaints under the Consumer Protection Act, Human Rights Act, Central Vigilance Commission Act, Charitable and Religious Trusts, Cigarettes and Other Tobacco Products Act, Production of Child Right Act, Insurance Regulatory and Development Authority Act, Maintenance and Welfare of Parents and Senior citizens Act, Right to Service Act, Domestic Disputes, Dowry Act, Child related issues, corruption issues, bonded labour, Custodial Encounter Death, human trafficing, Immoral Traffic Act and other allied Acts so enacted from time to time, Police Atrocities, National Integration and Communal Harmony, to promote feeling of universal brotherhood and mankind, to work for eradiction of social evils like drug addiction, SC/ST Act,. Legal Services Authority Act, Constitution, Jan Lokpal Bill, Citizen Charter and to do all acts, deeds and things related to above mentioned issues since its institution till its final adjudication and to complete all formalities in this regard i.e. representing the concerned person, engaging the representative/counsel, to pursue the matter from the lower courts to the highest court of law.

(ix)To arrange religious functions for character building of the youth.

(x) To work for eradication of social evils like drug addiction, dowry system from the society.

(xi)To arrange marriages of poor girls to help the needy parents.

(xii)To arrange medical camps, eye camps and blood donation camps for the welfare of the poor and needy patients.

(xiii)To arrange langer at the religious functions.

(xiv) To accept grants/donations from the general public and Govt. Authorities in cash or kind and to utilize the same for the welfare of mankind and to achieve the aims and objects of the society.

(xv) To work for national Integration and Communal Harmony.

(xvi)To promote the feelings of one-ness and brother-hood of mankind.

(xvii)All other acts, deeds and things of welfare and charitable character.

(xviii)To open, establish, run, takeover and maintain Vridha Ashrams, Stay Home and rehabilitation centre for distressed men, women, widows and girls and short stay home (Dharamshalas).

(xix)To help and render assistance to the poor, needy, sick, invalid, infirm, handicapped, aged and destitute and to those distress.

(xx) To help orphans, lunatics and indigent persons.

(xxi)To open literature publication house and built library for promotion and propagation of knowledge of literature.

(xxii)To open and establish worship places for the welfare of mankind.

(xxiii) To educate, to raise the moral and ethical standards of humanity.

(xxiv) To provide physical and financial help in case of famines, floods, earthquakes and other natural calamities.

(xxv) To conduct/organize and promote activities connected with the removal of untouchability, prohibition of alcoholic and other narcotic drugs and eradication of leprosy & beggars.

(xxvi)To assist financially or otherwise any organization/institution with this like charitable aims and objects.

(xxvii)To establish, maintain, takeover, support by donation or otherwise rehabilitation centers, educational and vocational training centers for poor.

(xxviii)To provide aid for the (i) Marriage of poor girls, (ii) Education of poor children like books, fees, uniforms etc. (iii) Livelihood of poor families.

(xxix)To accept donations, gifts, grants, subscriptions in cash or in kind for the furtherance of the objects of the Association.

(xxx)To seek co-operations of Organizations, Institutions, Companies, Local Bodies, Governmental/Non-Governmental agencies in India and abroad for the promotion of objects of the Association and to enter into agreement(s) with them for the best interest of the Association and to implement the terms of such agreements.

(xxxi)To borrows or raise funds to achieve the objects of the Association and to secure the payment of such money in such a manner as the association shall think fit.

(xxxii)To invest and deal with the funds of the Association in such manner as may be deemed fit.

(xxxiii)To incur expenditure and make all necessary financial arrangements for carrying on the work of the Association.

(xxxiv)To organize cultural shows, fairs, medical concerts, publish souvenirs etc. for raising funds for the promotion of objects of the Association and to seek approvals, sanctions, enter into agreements for the same upon such terms and conditions as are in the best interests of the Association.

(xxxv)To acquire by purchase, lease, donation, exchange or otherwise lands, buildings of any tenure or description or any estate or interest therein and any rights over or connected with land, building etc. either to retain the same for the purpose of the Association or to turn the same to account as may be expedient.

(xxxvi)To construct, build, maintain, improve, adopt, develop, manage, alter, furnish, sell, lease out, exchange or otherwise deal with all or any part of the property including land, building and other assets of the Association and to enter into agreements, contracts, receive earnest money, security, deposits etc. for the purpose.

(xxxvii) To help other voluntary and charitable institutions by way of donations, loans, grants etc. and to take over such institutions by lease, merge, purchase or otherwise.

(xxxviii) To open branches of the Association anywhere in India.

(xxxix)To carry on any kind of activity which can conveniently be carried on with the foregoing or which are necessary or conductive to the attainment of the objects of the Association or any of them and to carry such other Charitable activities which the governing body may approve from time to time.


(xxxx)To serve and help in making self dependent people who are backward economically, socially, educationally or in any form, to help the down-trodden and the victims of any natural calamity,floods, earth quake, drought, fire etc. by way of various programmes and projects.

(xxxxi)To inculcate the sense of belief courage and interest in organizing various service projects in the association and to encourage and co-operate with the selfless workless and organizations.

(xxxxii)That not withstanding any thing hereinbefore or hereinafter contained the income as well as corpus of the Association Fund shall be applicable and applied only to and/or for such charitable purpose as are recognized or defined as charitable under the Income Tax Act, 1961 and/or any other Law governing Taxation of Income and as will ensure or make the Association hereby established and its income eligible for exemption from taxation under the Income Tax Act, 1961.

(xxxxiii)All the income, earnings, movable or immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth above and no position thereof shall paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever, to the present or past members of the society or to any person claiming through any one or more of the present or the past members. No society shall have any personal claim on any movable or immovable properties of the society or make any profit, whatsoever, by virtue of this membership.

(xxxxiv)To do all such acts, directly or indirectly which may be helpful in the fulfillment of all or any one of the above mentioned objects.
